## 6.1 Overall conclusion on the level of compliance achieved

Despite the recruitment of some new official veterinarians in local veterinary services during 2023 there is still to be seen an increase in achieving the target of control plans in local veterinary services which remain understaffed, remaining this as a political decision to be made. The lack of personnel has acquired a systematic character with long-term impacts in Greek society and market. National legislation is robust and promotive, national procedures and criteria are well-established, the remaining inspectors are experienced and trained. They exercise official controlling and verification, monitoring and guidance for operators and dissemination of good practices and animal welfare improvements for all animal sectors. Their performance is correct but the operational work overload makes them not to obtain the action plan's strategic objectives. Parallel, for local veterinary services, there is a lack of financial resources too ( which is also a systematic and political issue too).

Official controls were performed in mixed sheep and goat farms (declared in both species' relevant sections). As far as welfare in slaughterhouses is concerned, regional veterinary services use the joint inspection protocol template for welfare and hygiene sectors during a slaughterhouse audit which in effect since 2021. Finally higher stocking densities, lack of complying with journey times quoted in documents, bad maintained vehicles with unsuitable drinkers and unprofessional behavior of drivers at road checks still remain the most frequent non compliances in transports with destination to Greece from other neighboring MSs.
