5.1 Overall conclusion on the level of compliance achieved

The overall picture of the Region ABP controls is recorded in the electronic ABP system (e-ABP) and includes the ABP management plants that were controlled, the date of the implemented controls, the number and type of non-compliances, the sampling as well as the penalties and sanctions imposed per ABP management plant. The arrangements for follow-up on identified non-compliances during official controls are described in article 3 of law 4235/2014 (as modified by law 4801/2021) and in article 13 (par.3) and Annex VI of MD 612/118658/2020. There is a corrective action plan which is completed by ABP operator and approved by competent authority. The verification of corrective actions implementation is made by competent authority through a follow-up audit.

During 2021, 1 fine was imposed by central competent authority (amounts > 6.000 euro) according to article 24 of Greek law 4235/2014 and MD 434/82574/25-6-2014 (incinerator HP). 10 approval codes from ABP operators were recalled (1 rendering cat.3, 1 incinerator LP and 3 incinerators HP, 1 DP storage and 4 intermediate plants).
