6.1 Overall conclusion on the level of compliance achieved

Like 2020 the COVID pandemic with practical restrictions including limit of persons in cars or many COVID positive personnel in an extended time limit was a handicap in achieving the target of control plans of local veterinary services. Regarding farm welfare, Inspections performed under the scope of cross compliance legislation revealed also some non compliances which are included in this report. These non compliances led to the reduction of subsidies to various percentages (up to 9%) according to the level of non compliance. Official controls were performed in mixed sheep and goat farms. As far as welfare in slaughterhouses is concerned, the central competent authority produced a joint inspection protocol template for welfare and hygiene sectors during a slaughterhouse audit. This led to an increase in the reporting of non compliances also presented in Part II, Section 1 of this Annex. Finally higher stocking densities and lack of complying with journey intervals seen in documents seem to be the most frequent non compliances in transports with destination to Greece from other neighbouring MS.
